- 4. New Business:
  - a. Mason County Promise Zone 2021 Budget (REF #1)
    - i. Contract with Chamber (2019-20 contract REF #2)
      - Review changes that affect budget: The Chamber rates for staff hours will not change, and the Chamber will continue to bill month-to-month on an hourly per use basis. Maloney will update the contract for Board review, and get updated costs. No changes were recommended.
    - ii. Marketing Committee 2021 Budget Projection (REF #3)
      - 1. Requesting an allocation for \$5367.00 for 2021
        - a. No changes to this request were recommended.
    - iii. Board Consulting
      - Recap of discussion with MPZA Executive Director Chuck Wilbur: Wilbur recommends a Board meeting (with Promise and or LCAN team) at which he would share a landscape view of existing LCAN/Promise partnerships before launching strategic planning activities.

    - iv. Success Coaching Incentives (REF #7)
      - 1. Budget options for review
        - a. Motion by Large to recommend adding funding for incentives up to \$11,500 based on the student success incentive budget option 2:

          Incentive Plan Option 2: First-years Complete one check-in w/coordinator, two Canvas modules, and attend at least two virtual Meetups (or watch online and provide a reflection), meet with an academic advisor once per semester; must meet 2.0 for continued eligibility for incentives in winter semester. Returners must maintain a 2.0 (or have an approved appeal and complete Strengths Coaching) and meet with an advisor each semester. Fall-Winter only.
          - Up to \$9000 at \$25 for up to 3x/semester of monthly participation for first year students and up to \$2500 at \$25/semester for semester-based participation for returning students.
