



**Mason County Promise Zone Appeals Committee
Meeting Minutes
Monday, December 2, 2024 at 11:00 AM
Lakeshore Resource Network Conference Room**

1. **Call to Order:** Knizacky called the meeting to order at 11:00 AM.
2. **Limited Public Comment:** None
3. **Approval of the Agenda:** Motion to approve the agenda by Nash, supported by Quillan; Motion carried 3-0-1.
4. **Approval of the Meeting Minutes:**
 - a. 8-19-2024—Motion to approve by Nash, supported by Quillan; Knizacky requested that Maloney check on past appeals to see if students attended (see attached); Motion carried 3-0-1.
5. **Committee Business**
 - a. Consideration of Student Appeals
 - i. Appeal #93—Winter Use of Promise while FT at Another University—Motion to recommend approval to the full Board by Quillan, supported by Nash; Maloney asked to clarify if another student has the same situation, whether they should plan to appeal, and Knizacky stated that other students interested in similar consideration will need to go through the appeal process; Motion carried 3-0-1
 - ii. Appeal #94—GPA—Motion by Knizacky to recommend to approval of appeal #94 contingent upon completing a SAP appeal, support by Nash; Knizacky noted that the Promise has not yet provided funding for the student in either semester attended; approved 3-0-1;
 1. Follow-up discussion: Quillan inquired whether the Promise could check if anyone at WSCC checked on the student; Maloney did not have that information. Knizacky suggested to invite WSCC to the January Board or Appeals meeting to address: What are the current interventions for failing students prior to final grades; What information could the Promise get to provide intervention as a board if WSCC does not have standard interventions? Maloney will reach out to the Dean of Student Services to request meeting with the Promise either the 13th of January full Board meeting or the January 27th Promise Appeals for a date.
 - b. Committee Charter Review: The consensus of the committee was to leave the Charter as-is, with no changes.
 - c. 2025 Meeting Schedule: Appeals Meetings will be scheduled at 11AM for January 27, May 19, August 4, and December 1, 2025. Calendar appointments will be sent after the location is confirmed.
