- 3) **Approval of Agenda:** Motion to approve the agenda from McLean, with clarification on whether the Joint Board meeting portion was intended and if quorum was present--Maloney clarified that that was in error and that only the Committee was at the meeting; Support from Surd; Motion passed unanimously.

- 5) Business:
  - a) Kennedy welcomed new WSCC Staff: Dr. Tami Wolverton, Director of Advising & Retention; Kalli Wahr, MCAN Completion Coach for Promise & Manistee Commitment Scholars
  - b) Promise Scholar Update: Maloney shared the following update:
    - i) Promise Numbers:
      - (1) 117 applicants from Class of 2021

(2) Fall 2020 Enrollment (see next page); WSCC is working on providing retention reports for May McLean requested information about graduates by cohort year, and Maloney said she could provide them adding that the three Scholars graduated in Fall 2020 were from the 2018 cohort.

- ii) FYS Update from WSCC, Annie Jacobson, Director of Enrollment and Student Engagement (see attached slides): 70 students enrolled last year, and 46 attended college; of those 46, 40 attended WSCC. Courses for Winter 2021 can be in-person, online or mixed delivery. Students in the class learn about WSCC resources, including Community Schools Coordination and CARE Team on campus.
- iii) Open Educational Resources Update (OER) from WSCC, Dr. Mark Kinney, VP of Academics & Student Services (see attached slides)



- iv) WSCC Success Coaching: Maloney shared that 5 Scholars were signed up for Success Coaching at WSCC, and Kalli Wahr, who is familiar with Mason County and a WSCC graduate is the new coach, hired by WSCC through the Michigan College Access Network College Completion Corps program. Wahr added that she is reaching out to Scholars through texting and phone calls.

### Promise Update:

- 117 seniors from the class of 2021 have applied for the Promise Scholarship at WSCC so far. School Counselors were working diligently, as always, during School Counseling Week last week to get more students applying. Applications were tracking about 30% down in January but that gap is closing. By February, applications were only 18% down. (3)
- Graduate update: 3 Scholars graduated in Fall 2020, from the 2018 cohort! WSCC now has cords on hand for Promise Scholars to pick up.
- Be sure to encourage the high school seniors you know to apply for the Promise by March 1 to earn a Promise Tee, and to complete their FAFSA as part of the local FAFSA initiative sponsored by Pennies from Heaven Foundation.

- All FYS courses went fully online March 16th
  - Internet access & connectivity problems for many students
  - Non-academic responsibilities (i.e., caring for younger siblings)
- WSCC closed to public as of March 23<sup>rd</sup>
  - Could not bring all groups to campus
- Many students unable to contact by phone or email
  - MCE 7/15 students failed or withdrew
  - MCC 5/37 students failed or withdrew
  - LHS 6/18 students failed or withdrew




### TEXTBOOK COSTS


- > 159 total books sold for classes offered at WSCC

## HISTORIC FALL ENROLLMENT




# EXPECTED FALL ENROLLMENT





### ACTUAL FALL ENROLLMENT




### WINTER STATISTICS

- ▶ 1,057 students enrolled
  - Down 7.4% from 1,142 last winter
- ▶ 10,224.57 contact hours enrolled
  - Down 5% from 10,760.29 last winter
- ▶ 32% of WSCC students are dual-enrolled (26.3% of credit hours)
- ▶ 66.6% of WSCC students are female
- ▶ 76.2% of WSCC students attend part-time
